

SB 1383 FAQ

What is SB 1383?

It is a state mandated law that requires recycling of organic food waste in order to achieve California's recycling & greenhouse gas (GHG) emission goals.

Who is impacted?

Everyone is impacted with SB 1383.

-Businesses that generate two (2) or more yards of solid waste weekly &

-Multi-family with five (5) or more units

-Single-family residents and multi-family with less than five (5) units.

What if I don't separate my food waste?

Check your City or County Municipal Code Ordinances as citations and fees may apply for anyone not in compliance. Also, contamination fees may apply.

I live in an apartment—am I impacted?

Yes, everyone is required to separate food waste.

I live in a house—am I impacted?

Yes, residents will be required to source separate food waste and place in the green cart with yard waste.

I am a business & do not generate any food waste—am I impacted?

Yes! To be compliant with SB 1383 a business needs to recycle other organic material like paper and cardboard.

Black/Grey—Trash

Only place non-recyclable, non-organic, and non-toxic in the trash container—this trash will be taken to the landfill for disposal.



Blue—Recycle

Only place recyclable items loose in the blue recycle container—**NO plastic bags**. Recyclables will be made into other products.



Green—Organic

Only place food and yard waste in green recycle container—**NO plastic bags**. Use kitchen pail to transfer to green recycle container.*
Organics will be made into compost.



* Ask us about a 13-gallon organic container for businesses.
